4. A Cleaning/Damage/Missing Equipment deposit of **\$50.00** and a KEY deposit of **\$50.00** is paid at the time this agreement is executed and shall be refunded if the premises are left in the same condition after the renter vacated as they were immediately prior to the occupancy and \_\_\_\_\_ key(s) is/are returned within 1 week thereof by renter. (Deposit Checks will be kept on file & will not be cashed)

Deposit will be refunded by mail or in-person after facilities have been inspected and assessed. Any extra expenses incurred for additional cleaning/damage or key replacement by BCRPD staff (or representative) will be deducted from the Cleaning/damage and KEY deposit.

5. The renter hereby warrants that they will be personally responsible for the cost of repair of any damage over and above that covered by the damage deposit. Renter recognizes that the BCRPD is not responsible for lost or stolen items of any kind

6. If Cancellation is necessary, renter must cancel at least (14) days before rental date, or rental fee will NOT be refunded. Damage deposit will be refunded fully.

7. **PLEASE:** Alcohol of any kind is **not** permitted in any of BCRPD facilities. Do Not Park on the Blacktop, loading and unloading only!!

8. **Indemnification:** Renter agrees to be solely responsible for any and all liability, claims, loss, damages, costs and experience, including attorneys' feed, arising out of or resulting from any injury to persons or damage to property which arise out of its use of the districts facilities
